In April 2009 the doors of the Family Justice Center opened with the stated goal of creating a one-stop-shop for victims of domestic violence. In just nine months, the Family Justice Center has made a difference in the lives of many **Montgomery County families** living in the shadow of domestic violence. More than 1,000 people, representing 97 different countries, have received services at the FJC. For many of them, coming to the FJC was the first step they had ever taken to end the violence in their lives.

As the State's Attorney for Montgomery County, I am charged with prosecuting crime and holding offenders accountable for their actions. The FJC plays a crucial role in assisting me with this job. By offering victims of domestic violence counseling, emergency assistance, help with obtaining protective orders, and other services, the FJC

removes barriers that so many immediate and comprehentimes leave a victim feeling both helpless and hopeless. The empowerment of these more successful prosecutions.

This empowerment comes from the hard work of the staff of the FJC, which includes its on-site partners, Catholic Charities, the Abused



Persons Program, the House of Ruth, the Domestic Violence Section of the Sheriff's Office, and the Family Violence Division of the State's Attornev's Office. Because of the FJC, victims receive more

As a result, victims victims has already resulted in are stronger and better able to assist us in holding their abusers accountable, better able to protect themselves and their children, and better able to help make our community safer by keeping dangerous people off the streets.

Our ultimate goal is to eradicate domestic violence. Recognizing how daunting a task that is, I am cautiously optimistic that the work of the FJC will assist in ending the intergenerational cycle of violence. For every mother or father who stops the violence in their home, and consequently saves their child from experiencing violence on a daily basis, that parent is making it less likely that his or her child will grow up and continue in that cycle of violence. Every day at the FJC brings new hope to our community.

Sheriff's Office Receives Award from MNADV

The Maryland Network Against Domestic Violence conferred its annual law enforcement award on the Montgomery County Sheriff's Office this fall for its leadership in the creation of the Montgomery County Family Justice Center. The MNADV, now in its 29th vear, is the state coalition of domestic violence providers and their allies. The

Law Firms Provide Pro Bono Help to FJC Clients

Many times, domestic violence in the immigrant community is hidden because victims are hesitant to come forward due to their legal status. When they do come forward, however, lawyers from the law firms of Dickstein Shapiro LLP and Hunton & Williams are available to conduct intake and answer questions about immigration related legal options. Through a partnership with Catholic Charities, these firms are generously donating their time and expertise to staff an

office at the FJC four afternoons a week. (The law firm Sidley Austin provided a lawyer to help with the day-to-day set up in the opening weeks of the FJC.) Once clients have gone through intake at the FJC, Catholic Charities finds pro bono lawyers to represent them before the U.S. Citizenship and Immigration Services office and the immigration court.

Because of these firms' efforts, approximately sixty FJC clients have gotten top-notch legal assistance from the area's top immigration experts. Volunteer lawyers from these firms are not only helping FJC clients untangle their immigration problems, but are also helping victims find legal pathways to citizenship through laws such as the Violence Against Women Act (VAWA), U and T Visas for victims of crime and trafficking, respectively. Some of these clients have already been granted citizenship and relief from deportation.

Choose Respect Montgomery: A Success!

The Domestic Violence Coordinating Council and its County partners hosted Choose Respect Montgomery Teen Dating Conference for local teens and their parents. Over 160 teens and parents attended the conference and participated in educational workshops throughout the day on topics related to healthy and unhealthy teen dating behaviors and misuse of technology.

The day opened with a welcome address from State's Attorney John McCarthy and the presentation of the Teen Dating Proclamation by County Council President Phil Andrews. Before breaking out to workshops, the participants were treated to an outstanding performance by City at Peace DC. Five young members of the youth development organization acted out a real life abusive teen dating sce-

nario. The performance was informative and offered the perfect balance between the reality of abusive teen relationships and comedic relief.

The afternoon began with three inspirational messages. Chief Deputy Darren Popkin kicked off the program and emphasized the importance of intervention through reporting incidents to (Cont. page 8)

Does My Support Make a Difference?

Any offer of support goes a long way to a woman or child in need at the Family Justice Center. As a supporter of the FJC, I've had the opportunity to meet and help many families in our community. Recently, I worked with a County resident and mother of two elementary school children to obtain a protective order and to begin divorce and custody proceedings after her husband threatened to kill her and their children. This threat followed many years of violence and intimidation in the family home. The FJC referred her to me for representation in legal proceedings but also provided her and the children with mental health

counseling from qualified professionals, assistance and education about the criminal process from the State's Attorney's Office and, most importantly, a safe and welcoming place for her and her children to go in their time of desperate need. Here is what she had to say about her experience at the FJC:

It's a really good resource to have everything in one place. They had a counselor there that helped me a lot. It's a beautiful facility. The FJC is much more family friendly than another place we went to. Every time that I went to the FJC, I was asked if I or my kids wanted juice or food. They know that people will come when they are in crisis and they may not have thought about food before they had to leave their homes. Having people from the Abused Persons Program, the attorneys, the sheriffs and the counselors in one place was very helpful. I'm so glad the FJC is there for us.

Safeway Awards Grant to FJC Foundation

Bill Mitchell, President of the Kristin Mitchell Foundation showed a touching video of his daughter Kristin and spoke of his daughter's abusive relationship that ended in her murder, just after her college graduation. A youth survivor also spoke of her experience in an abusive relationship and the courage it took for her to leave.

The day ended on an exciting note with Attorney General Douglas Gansler announcing the winners of the Teen Dating Public Service Announcement Contest and a raffle. Parents and teens alike expressed appreciation for the conference and requested it become an annual event in Montgomery County.

In presenting the award to the Sheriff's Office, Eugene Morris, President of the MNADV described the Montgomerv County FJC as a model of the coordinated community response that advocates see as the key to ending partner abuse. He commended the Sheriff's Office for the way it has fostered respectful cooperation among victim advocates, service providers and law enforcement agencies while creating a beautiful, warm, user-friendly site to receive services for families suffering from domestic violence.
