Every year, I watch our community come together in support of our Family Justice Center (FJC), and this support comes in so many forms. Whether it's donating brand new toys and stuffed animals, bringing in essentials like umbrellas and winter coats, handknitting hats, scarves, and mittens for children, or donating money for grocery store gift cards, the residents of Montgomery County care for their neighbors, and will help in whatever ways they can to ease the suffering of those experiencing violence in their homes. It is this community support that makes Montgomery County such an incredible place to live, and on behalf of everyone at the FIC, we are humbled by your kindness and generosity.

As we approach the FJC's ninth anniversary, and nearly 10,000 victims served, we are reminded that much work remains to be done. The 2017 fiscal year saw a 10% increase in Protective Order filings over the previous year. Research tells us that I in 4 women and I in 7 men have been victims of severe physical violence by an intimate partner in their lifetime, so in a County of more than 1,000,000 people, it is critically important that we have adequate resources to respond to these incidents as they arise. In addition to responding, we must also utilize prevention efforts to break the cycle of violence for good.

In the coming year, we will continue to encourage our teenagers to be respectful and engage in healthy relationship behaviors. The 9th Annual Choose Respect Conference will be held on Sunday, April 15, 2018 from 12:00pm – 4:30pm at Richard Montgomery High School. Students, parents, youth service providers and educators

will participate in separate, interactive, age-appropriate workshops to discuss important issues related to domestic violence such as the warning signs of abuse, the effects of dating violence, and what to do if you or someone you know is being abused by a dating partner. I would encourage any and all of you to attend this important event, which will include free food, raffle prizes, and much more. The Choose Respect Initiative also offers free, in-person, interactive presentations on dating violence throughout the year that fit into a standard class period. Smita.Varia@montgomerycounty md.gov. This critical prevention initiative is managed by the Montgomery County Domestic Violence Coordinating Council (DVCC) and funded by Verizon through its partnership with the Montgomery County Family Justice Center Foundation.

New to Montgomery County's safety net for victims of domestic violence is the Safe Passage Center (SPC). Conveniently located in Rockville, the SPC provides supervised visitation and monitored exchange services for Montgomery County families. Too often, we see child exchanges end in conflict, harassment, and even violence, so the SPC is a welcome and exciting addition to the wide array of support available in our County to keep families safe.

To all of those who worked tirelessly nine years ago to make the FJC a reality, to those who continue to provide their ongoing support, and to those FJC staff who work day after day to keep our community safe, you have my sincerest gratitude. Wishing a joyous, healthy, and above all, a safe 2018 to all.



Domestic Violence Coordinating Council'sChoose Respect Montgomery Initiative

The Domestic Violence Coordinating Council's mission is to reduce the incidence of domestic violence and create a safe community for families to live free of abuse. One of the initiatives to achieve this mission is Choose Respect Montgomery. Choose Respect Montgomery includes four programs: an annual conference for teens, their parents, educators, and youth service providers; a public service announcement video contest for teens; Expect Respect—the healthy teen dating curriculum presented in the County's middle and high schools and Coaching Boys Into Men, which utilizes the unique role of coaches in the lives of young male athletes to teach them to be respectful both on and off the field.

The Choose Respect Conference:

The Choose Respect Committee is already working hard on the 2018 Choose Respect Conference. The conference will be held on Sunday, April 15th from 12 pm to 4:30 pm at Richard Montgomery High School. The conference is for 6th—12th graders, their parents, educators and youth serving providers. There will be a resource fair with community organizations represented, an opening session, workshops, raffle prizes and food. The students who attend will receive Student Service Learning Hours. Registration will open in March 2018.

The PSA Contest:

Students are asked to create a 60 second video PSA addressing emotional, verbal, financial, or technological abuse. The first place prize is \$1,000, with 2nd and 3rd prize getting \$750 and \$500 respectively. The winners of the annual PSA contest will also be announced at the conference.

Expect Respect:

The Expect Respect Presentations, approved by Montgomery County Public Schools, are 45 minute in class presentations for 8th—12th grade students. Through interactive discussion, videos and activities, students learn about dating violence, warning signs, and how to help a friend. They also hear about the resources available to get help. This semester, the facilitators have already reached over 1,800 students!

Coaching Boys Into Men:

The Domestic Violence Coordinating Council is working with Montgomery County Public Schools to implement Futures Without Violence's program Coaching Boys Into Men (CBIM). CBIM is a free toolkit that utilizes the unique and important role that coaches play in the lives of young men. These comprehensive tools assist coaches in planning important discussions with athletes about respect for women and girls, and that violence doesn't equal strength. Through CBIM, male athletes learn skills to avoid violence and abuse in their relationships. The football teams at Springbrook High School, Montgomery Blair High School, Richard Montgomery High School and Northwest High School are implementing the program, in addition to Magruder High School's Weight Room classes. Safe Start... Breaking the Cycle of Violence

The MCFJC Foundation continues its critical partnership with Montgomery County's Safe Start program. This multi-faceted partnership provided through Chesapeake Counseling continues to provide enhanced psychological services for children who have witnessed domestic violence at home.

The generosity of the Montgomery County Recreation Department in partnership with the Foundation's "Send a Kid to Camp" project enabled Chesapeake Counseling to select twenty-one children from Safe Start to attend the County's Summer Day Camp program. More children are expected to participate in 2018.

Chesapeake Counseling therapists also work with the staff from the Montgomery County Sheriff's Office and the Office of the State's Attorney to present Expect Respect- a dating violence program under the Domestic Violence Coordinating Council- to middle and high school students. In 2017, Expect Respect was presented to over 2,300 students. This interactive school program addresses healthy and unhealthy relationships, different types of violence and provides community resources.

Margaret Mead once said "Never underestimate the power of a few committed people to change the world. Indeed, it is the only thing that ever has." Thanks to the commitment of our team at the Montgomery County Family Justice Center Foundation, we raised almost \$6,000 for domestic violence awareness programs. This amount will be partially matched by the Allstate Foundation. The MCFJC Foundation was one of more than 220 nonprofit organizations urging the public to support survivors of domestic violence and raising awareness around financial abuse during The Allstate Foundation Purple Purse® Challenge, which took place in October.

On an average day in 2016, 12,000 requests from domestic violence and financial abuse survivors for services such as childcare and rent went unmet across the coun-

try. In Montgomery County, the Family Justice Center has served over 9,000 people since 2009.

In 99 percent of domestic violence cases, victims will experience financial abuse. Financial abuse is when an abuser denies their partner access to money and financial resources to live their life. It is another way for the abuser to control their partner, and leaves them with no financial means to leave an abusive relationship. Without resources of their own, victims are often unable to care for themselves and their families, find employment and housing, or save for the future.

As part of the challenge, we received a purple purse from the Allstate Foundation designed by tennis champion and Purple Purse ambassador, Serena Williams. The Board of Directors decided to present the purse to the team member who raised the most money. Congratulations to Cheryl Kravitz (pictured with Executive Director Resa Levy), who engaged the newest team members and raised the most money.

Helping to support the survivor through their legal challenges

Survivors of abuse often report that financial abuse has been one of the types of abuse they have suffered. Therefore, while the abuser may have access to funds, the survivor does not, which leaves many survivors without an option to leave an abusive relationship because they have no way of supporting themselves or their children. Given the fragility of the survivor at this critical time, legal representation may make the difference between the survivor wishing to leave the relationship or staying.

The MCFJC Foundation, aware of the critical nature of providing legal assistance, raises funds to help support its partnership with DVS Legal Services. DVS Legal Services is then able to provide critical pro bono and lo bono legal services to survivors. Since the inception of the Foundation's Legal Initiative, and the establishment of our "Clearinghouse" approach to engaging legal partners, 1,569 protective order cases have been monitored.

Since September 2016, DVS Legal Services has provided an attorney for 139 protective order cases, prepared an additional 9 cases where an attorney was not available in the quick turn-around time needed, and assisted other attorneys in another 3 cases. Additionally, we are excited that there is a new referral partner for the Clearing-house from the Jewish Coalition Against Domestic Abuse. DVS has provided legal assistance in approximately 323 cases - either with direct representation, referrals to other attorneys or pro bono organizations or general/specific legal advice.


